Subject: The interim dividend payment

Attention: President of The Stock Exchange of Thailand

Asia Aviation Public Company Limited ("the Company") held the Board of Directors Meeting No.6/2016 on November 9, 2016. The meeting resolved to approve the interim dividend payment for the period January 1, 2016 to November 11, 2016 at the rate of 0.15 baht per share, totaling 727,500,000 baht. The shareholders, who will be entitled to receive dividend shall be shareholders whose names are registered in the share register of the Company as of November 24, 2016 (the "Record date") and the Company will collect the list of shareholders under Section 225 of Securities and Exchange Act B.E. 2535 by way of closing the share register for suspension of the share transfer on November 25, 2016. The dividend payment date has been scheduled on December 7, 2016.

The interim dividend payment is based on the Company's performance during the period January 1, 2016 to November 11, 2016 because the Company's main revenue comes from the dividend payment of Thai AirAsia Co., Ltd., the subsidiary company and the core business operator. On November 9, 2016, the Board of Directors of Thai AirAsia passed a resolution to approve the interim dividend at the rate of 30.80 baht per share (the Company hold 23,955,553 shares or 55% in Thai AirAsia). As a result, the Company recognized dividend income from Thai AirAsia of 737,831,032.40 baht and on November 11, 2016, the Company reported Unappropriated retained earnings of 750,142,003.43 baht. With a due consideration, it appears that the level of retained earnings is sufficient to pay the interim dividend as per the aforementioned details.
