Preliminary Operating Statistics

For the 3rd Quarter 2021



Asia Aviation Plc is pleased to announce the operating statistics for the 3rd Quarter of the Financial Year 2021 ("3Q2021").

Given the worsening epidemic situation of COVID-19 during the third wave that began in April 2021, the Civil Aviation Authority of Thailand ("CAAT") made an announcement that operations for airline operators is to be prohibited for passenger flight operations in some restricted regions and the red zone and government continued imposing travel and movement restrictions. As a result, Thai AirAsia ("TAA") announced the temporary suspension of all scheduled domestic, commercial flight operations starting July 12, 2021, in support of the containment efforts by the government of Thailand until September 2, 2021. Consequently, TAA carried only 79,767 passengers or down by 96% Year-on-Year ("YoY"), in relation to its Available Seat Kilometres ("ASK") and capacity deduction. During the quarter, TAA recorded a load factor of 60%. Nonetheless, TAA has resumed its domestic operations from September 3, 2021, as travel restrictions were eased with the social distancing measure.
