# **Preliminary Operating Statistics**





Asia Aviation Plc is pleased to announce the operating statistics for the First Quarter of the Financial Year 2023 ("IQ2023").

In 1Q2023, Thai AirAsia's ("TAA") load factor reached a record high of 92 percent, up 2 percentage points ("ppts") from the prior quarter ("4Q2022"). The persistent pent-up travel demand, unwavering government's campaigns on Thailand's tourism, and increased flights, especially to China, which announced the reopening of its borders on 8 January 2023, have led to strong passenger traffic of 4.6 million, up from 1.5 million in the first quarter of 2022 ("1Q2022"), while still accelerating from 4.1 million in 4Q2022.

During the quarter, TAA resumed eight routes to China from Don Mueang to Guangzhou, Chongqing, Changsha, Kunming, Wuhan, Nanjing, and Chengdu, and from Chaing Mai to Beijing. This totaled to 67 flights per week by the end of March 2023, or 16 percent of TAA's total international flights per week. TAA also resumed its route from Don Mueang to Macau for five flights per week and introduced a new route from Don Mueang to Jakarta (Indonesia) for one flight per week. Furthermore, new routes were added to better serve and reinforce the connections of international travellers departing from Chiang Mai and Phuket hubs, including Chiang Mai to Hong Kong, Chiang Mai to Singapore, Phuket to Hong Kong, and Phuket to Singapore. Overall, TAA's international flights have recovered by 59 percent compared to the pre-pandemic level.

On the other hand, TAA's domestic market leadership showed a stronger momentum with the market share hitting a record 37 percent, driven by domestic flight recovery of 89 percent compared to pre-pandemic level.

At the end of the quarter, TAA operated 45 aircraft out of a fleet of 54 aircraft. One aircraft was still in the process to be redelivered in the next quarter.
